Blaze **Destroys** House

DOMINION CITY, Man. (Special) - A one-room frame house on the Roseau Indian Reserve near here was burned to the ground early Wednesday by what is believed to be a gang of arsonists.

Alex Johnson of the reserve said he was awakened twice during the night by noises outside his house. Rushing outside he saw a small group of men run across the clearing beside his house and disappear into nearby bush.

Mr. Johnson, his wife and three children escaped unharmed from the hlaze. There was no insurance

Two Deep Cuts

The jury ruled that Mrs. Sytnyk died tifrom shock and bleeding as a result of a severe beating administered by a person or persons unknown."

Dr. Stewart Lauchlan, pathologist at the Winnipeg General Hospital told the jury there were two deep cuts on the woman's scalp. He said she was badly bruised and several of her ribs had been broken.

Constable Albert Sorokowski testified that when he arrived at 649 Melrose Avenue he was directed to the basement of the home by Mr. Sednyk, the dead woman's son.

Const. Sorokowski said he found the nude body of Mrs. Sytnyk lying on a bed in the basement. There were visible bruises to the body and head, he said.

Blood On Bottle

East Kildenan police chief Chris Einfeld told the jury he found a whisky bottle which had blood stains on the label, and saw under the kitchen table a butcher knife with "what appeared to be blood stains on the blade."

 Chief Einfeld said there were blood stains on the living room floor, on the tile of the bathroom

floor and several spots on the kitchen floor

He said there were smears th which appeared to be blood on P the stairs leading down to the bi basement.

Dr. Bryson Murray placed time of death sometime between 7 and 8 p.m. of March 8. The inquest was held at the Law-Courts building.
